

## Children Code of Conduct

Club members with accompanying minors are responsible for the conduct of their children and their children's guest while they are on Club property. Failure of a member's child or the child's guest to adhere to the Club rules may result in disciplinary action to the responsible member including loss of Club privileges, as well as financial responsibility of the member for any damages caused by the member's child or the child's guest. Unless waived for special events, the following rules apply to the use of Club facilities by children:

### Guiding Principles

- Club members with accompanying minors are responsible for their children's behavior at all times.
- Children are expected to act in a responsible and appropriate manner at all times.
- Keep your children's safety a priority by ensuring their supervision by a designated adult **at all times**.
- Children at Coronado Yacht Club must demonstrate respect for members, visitors, and staff at Coronado Yacht Club. Common courtesy and sensitivity to the rights of others shall guide their behaviors.
- Ethnic, disability, or sexist jokes, racial or religious slurs, taunting, cursing, and intimidating behavior will not be tolerated.
- Children are expected to demonstrate good sportsmanship in all areas of play at the Club and when representing the Club at away activities.

### Clubhouse Conduct

- Children at the Club are expected to conduct themselves in a manner respectful of other members and staff. In order to provide a safe and pleasant atmosphere for everyone, all children shall remain seated while in the dining areas. Playing on the floor, running around and other similar activities are dangerous to members and staff and prohibited.
- Children under the age of ten (10) must be accompanied by an adult or responsible older sibling when they enter the Clubhouse.
- While at the Club, parents are to prevent their children from playing in the restrooms, running or wandering unsupervised in any area of the Club.
- Persons under 21 years of age are not allowed in the Club bar except for the area identified as the "Marlin Room" and when in the Marlin Room they must be accompanied by a person 21 years of age or older. Persons under the age of 21 years of age may pass through the Club bar when accompanied by a person 21 years of age or older.
- Running and playing should be limited to the side lawn area. It is dangerous for Children to be running around the exterior of the Club by fire pits and doors.
- Yelling/screaming indoors are not acceptable behaviors.
- The restrooms of the club ARE NOT play areas and should not be used for that purpose at any time.
- Children should NEVER be left unaccompanied by the Club's patio fire pits

- Bar will be open every day during in-season hours: Monday, Tuesday & Thursdays from 4:00p-8:00p.
- During our off-season, the Bar will be open on Mondays for Monday Night Football season only.
- No outside alcohol is permitted except for wine. You must bring your wine bottles to the bartender and pay a \$5.00 corkage fee and receive a corkage label.

### Club Events

- Any member can sign up for our Club events at the Blue Books at the front counter, by e-mail, text or phone.
- Any Club event with an inclusive per person charge has a 72-hour-cancellation policy. Any changes to the reservation must be made before this period, or the member will be charged for the original reservation.

### Private Events

- Private Events must be sponsored by a CYC member.
- All food must be catered by the CYC restaurant.
- No outside alcohol is permitted. All alcohol used for an event must be purchased through CYC.

## Membership

The CYC Flag membership total is limited to 650. This includes Flag, Jr. Flag and Social members. Other membership types/statuses are: Absent Flag, Life Flag, Senior Flag, Junior (Paying & Non-Paying), Deferred, Temporary and Honorary. Deferred Membership can only apply to Junior members over the age of 21. Membership privileges extend to spouses or registered domestic partners and all unmarried dependents under 21 residing in the member's household (excludes Junior membership).

A full application is necessary to new applicants, members that are flagging up to Jr. Flag and/or Flag or reinstating from Deferred status. To apply for any membership *status*, a written request to the Board of Directors is required for inclusion into the Board meeting agenda.

All Flag and Jr. Flag members must pay an initiation fee prior to the start of their membership. Please see the initiation fee scale to the right:

## Flag

**Rights:** property rights, use of all Club facilities, vote on all matters of Club business, hold elective office, reciprocity privileges, family & guest privileges, fly the Club burgee, enter a yacht in Club races, have a private signal registered with the Secretary.

**Age:** 21+

**Dues:** \$125.00

**Different Status:** Absent Flag, Senior Flag, Life Flag

## Junior Flag

**Rights:** use of all Club facilities, reciprocity privileges, family & guest privileges, fly the Club burgee, enter a yacht in Club races, have a private signal registered with the Secretary.

**Age:** 21-34

**Dues:** \$62.50 (½ of Flag dues for the first 5 years), \$125.00 thereafter (100% of Flag dues)

**Different Status:** Absent Jr. Flag

## Social

**Rights:** use of all social activities including usage of food & beverage facilities, family & guest privileges, attendance at special events and cruises, reciprocal privileges.

**Age:** 21+

**Dues:** \$175.00 (\$50.00 above Flag dues)

## Junior

- Rights:** use of all Club facilities, fly the Club burgee, enter a yacht in Club races, have a private signal registered with the Secretary.

**Age:** 7-24

**Dues:** \$25.00

**Different Status:** Deferred

## Monthly Statements & How to Pay

Membership dues & fees are billed at the beginning of every month and are due on the 22<sup>nd</sup> of month. Membership dues are billed in advance whereas all other fees (slip, restaurant & bar, retail, etc.) are billed in arrears.

If you are 60 days late, your charge privileges may be revoked for one year. The one year period will continue to be extended until the account is paid in full. If you are 90 days late, you may be brought up in the next month's Board meeting to discuss the standing of your membership.

Members can pay cash or check for their member payments when at the Front Office. Credit card member payments are now only accepted online (with 3% fee) through PayLease. Members also have the option of enrolling in ACH, automatic debit withdrawal on the 15<sup>th</sup> of the month, through a checkings or savings account.

## Public Website/Members Only Page

All members have access to a personalized "Members Only" section of the CYC website. On the main page, click on "Members Only" located on the top right of the website. Your username/password is:



Members have access to their monthly statements, Whisker Poles (also on public page), minutes to Board meetings, current CYC Yearbook, and current slip lists. When paying your monthly statement with a credit card, make sure to click on the blue "Pay Online" button under your statement balance to be led to PayLease, our 3<sup>rd</sup> party online credit card processor.

## Member/Guest Privileges

Guests, except those holding guest cards and members of recognized yacht clubs, shall be accompanied by a Member when on Club premises at all times. Members are responsible for the actions of all of their guests.

A member (excluding Junior) can extend guest privileges to a non-member for a period of 10 days by obtaining a guest card at the front office. No one guest may be given more than three guest cards per calendar year. These guest cards may not be for consecutive periods. A member may obtain five guest cards per year.

## Reciprocity

If you would like reciprocal rights at other yacht clubs, the Front Office can draft up a letter of introduction/reciprocity for you. We will send it straight to the receiving Club and also give you the original for your own records. Please inform the CYC office employee of when you are planning to arrive at the said yacht club, how long you will be there and who you will be going with. Contact the Front Office for more details.

## House Rules

- The Clubhouse is a non-smoking facility.
- All persons inside the Clubhouse must be dressed appropriately and wear shoes (bathing suits are not considered to be appropriate). Open-toed shoes are acceptable.
- Skating, bicycle riding, roller-blading, and scooter-riding are not permitted on docks or on porch areas. Skates and roller-blades must be removed before entry into Clubhouse areas. Skate boarding is not permitted on Club premises.
- Washing vehicles is prohibited in the Club parking lot.
- Speed limit in parking lot is five (5) miles per hour.
- On no occasion shall any Member/Membership have more than two (2) vehicles or utilize more than two (2) spaces in the Club parking lot.
- Public parking is accessible on the other side of the Clubhouse, near the side lawn area.
- Head keys and gate openers can be purchased by members only at the Front Office.

## Slip Rules

- Swimming and fishing are not allowed from the docks at any time, but are permissible off of a vessel.
- The front main dock can be used by any member/reciprocal member for up to a maximum of two hours. A courtesy call in advance is always appreciated.
- Use of the dinghy dock is limited to vessels less than 14' LOA. A dinghy decal must be obtained from the front office.
- Each slip is limited to one approved fiberglass dock box that must be approved by Director of Facilities.
- A member who removes their vessel from the Club premises for more than 24 hours must complete a Float Plan at the front office.
- Subleasing of a wet/dry slip is prohibited.
- Sale of a vessel in the CYC marina does not come with a CYC membership or slip.
- Boats assigned to a wet or dry slip will not be moved to another without the approval of the Port Captain.
- Rafting of boats to other boats in CYC slips is prohibited except with the approval of the Port Captain.
- Club hoists can be used by staff and members that have been trained by the Director of Facilities. A key can be obtained with the approval of the Director of Facilities at the front office.
